    - Staffing Update Wendy Silva updated the Commission regarding current staffing for Stanislaus Regional 9-1-1, and the recent 9-1-1 outage due to AT&T fiber optics being vandalized. Planning to add 3 additional lines to citizens to call 7 digit version of 9-1-1 (558-HELP) for future outages. This telephone number will connect

to Stanislaus Regional 9-1-1 directly. OES is coordinating a meeting to plan for future outages. This was the fourth occurrence in the last two months in our service area. Questions were raised about AT&T having a redundant system as back up. OES has determined to not be solely dependent on AT&T in the future due to these events.
