I. Open and Welcome

Urgent Matter

County Counsel, John Doering, and City Attorney, Adam Lindgren, requested the Commission to add a matter to the agenda for closed session to discuss recent staffing emergency at the Agency. Pursuant to Government Code Section 54954.2 (b)(1), the Commission may add this matter to the agenda upon a determination by a majority vote that an emergency situation exists, as defined in Section 54956.5.

Section 54956.5 defines an "emergency" as a work stoppage, crippling activity, or other activity that severely impairs public health, safety or both. Upon a 2/3 vote of the Commission, the discussion may be held in closed session. (§ 54954.5 (c).)

In this case, the Agency has experienced an unprecedented absence of dispatchers, which has adversely affected operations of the Agency, and which could pose a threat to the security of essential public services.

Counsel recommends that the Commission:

- 1) Find and determine that the absence of dispatchers poses an emergency situation that severly impairs both public health and safety which poses a threat to the security of essential public services; and
- 2) Pursuant to Government Code Section 54957, add to the agenda a closed session matter titled:

Threat to Public Services. Consultation with: Deputy City Manager Joe Lopez, Assistant Chief Executive Officer Jody Hayes, Stanislaus County Fire Warden Dale Skiles, Modesto Chief of Police Galen Carroll, Human Resources Management Consultant Cari Griffin, Interim SR 9-1-1 Director Wendy Silva, Stanislaus County Counsel, Modesto City Attorney, and members of the law firm Renne Sloan Holtzman Sakai LLP,

Recommendations: 1) Approve the Stanislaus Regional 9-1-1 2016/2017 Proposed Budget, which uses the Status Quo Budget as its base along with the implementation of cost reduction recommendations Options A, B, and C, for a total net annual budget reduction of \$644,431; 2) Approve new policies to address costs outside of the six fixed-post model; direct billing special event costs to benefiting partners at year-end and charging non-partner agencies for service costs related to radio infrastructure and maintenance; 3) Direct SR 911 staff to validate the most recent CAD incident counts, finalize the allocation of 2016-2017 costs using the approved allocation methodology, and send notifications to all partner agencies of the individual allocations resulting from the Recommended 2016-2017 Proposed Budget; and 4) Direct SR 911 staff to present a mid-year budget review to the Advisory Board and Commission prior to January 1, 2017 and annually thereafter.
