6.1 Monthly Dispatch Operations and Staffing Report for October, 2017

Stanislaus Regional 9-1-1 (SR911) Operations and Technical Services Division Manager, Wendy Silva, presented the enclosed report.

6.2 Status Report Regarding SR911 Technical Projects

Wendy Silva discussed technical projects. Commissioner Carroll inquired if the console will be completed by the end of the year. Silva responded that it will depend on the interface with Tri-tech. Once it's received Silva will be able to provide a timeline.

6.3 Oral Update from SR911 Executive Director

SR911 Executive Director (Director) Scotty Douglass (Douglass) gave an update on the office remodel. President Ridenour asked about the OES Activation center and requested an update. Director Douglass provided a high-level update as to the progress of the 3705 Oakdale Rd., Modesto building remodel and referred the Commission to the Deputy OES Director for further information concerning the EOC operations within the new spaces.

Director Douglass shared when he entered into contract with Avtec Inc. to purchase the radio console there was approx. \$100,000 remaining in the project budget for unplanned items or professional services that may surface. Director Douglass advised SR911 will likely need to use the remaining funds to add a Voice Recording System and Associated Interface Software Equipment and to add a Software Interface Connection to the Computer Aided Dispatch (CAD) System in order to complete the project. Furthermore, Director Douglass advised the Commission that they should expect a future request from staff.

Director Douglass shared that he has been discussing opportunities for technology partnerships with other cities for systems such as dispatch radio console systems, Computer Aided Dispatch (CAD), and telephone systems.

#### 7.0 Commissioner Reports.

President Ridenour shared that he had a scheduled tour with Stanislaus Regional 911. He sat with one of the primary Sheriff dispatchers and sat with a Call-taker. President Ridenour shared how impressed he was with the dispatcher and call taker. Director Douglass shared that there was a positive reaction from staff.
