5.0 Regular Agenda

5.1 Approve to Amend Stanislaus Regional 9-1-1 Capital Improvement Project 2017.02 "Building Uninterruptible Power Supply (UPS)" to 1) Include Additional Technical Redundancy and a Revised Budget not to Exceed \$124,632.11, and 2) to Allocate \$59,632.11 from the SR911 Contingency Reserve Fund to Support the Increase to the Project Budget

Stanislaus Regional 9-1-1 (SR911) Executive Director (Director) Scotty Douglass shared the UPS project was part of the Capital Improvement Plan with a budget of \$65,000 allocated towards that project. Since that time there was a failure to the UPS. There is a component inside the UPS that switches power over from shore power over to generator power. There was a failure in the switch over which caused a blink of power and caused all computers to reboot. After this glitch, staff went back to the drawing board and looked at the specifications with technical staff. SR911 technical staff consulted with the existing UPS vendor and it was recommended to purchase a dual-string battery which will provide an internal backup system, to avoid future down-time. The purchase of a new UPS will require an increase to the budget not to exceed \$124,632.11, that includes a 17.5% contingency. Staff is requesting to allocate \$59,632.11 from the contingency reserve fund to support the increase to the Project Budget. This was shared at the November Dispatch Advisory Board meeting and the Advisory Board supports and recommends the budget being increased in favor of increasing the capacity and redundancy of the UPS.

Motion to Approve to Amend SR911 Capital Improvement Project 2017.02 made by Commissioner Lopez, seconded by Commissioner Murdock. Approved 5-0 unan.

Commissioner Hayes also thanked Wendy Silva and her entire team for their hard work. President Ridenour thanked Douglass for doing a great job.
