7.0 Commissioner Reports.

Commissioner Carroll (Carroll) shared he is gathering Modesto Police Department call data for the last 5 years to review with his Command staff at their retreat on January 31. They will be looking at redesigning the police department. Carroll is looking at what they respond to, what type of calls they are going to and whether civilians can handle more of those calls verses officers. Once he gets at the information he will share with Silva. Commissioner Chiesa questioned how the cellular service for 911 call volume

charges are billed. With the move away from CHP how is the money allocated to 911 dispatch centers. Silva will research and follow-up.
