1.0 Open and Welcome

Meeting called to order at 1:02 p.m. by President, Doug Ridenour, Sr.

President Ridenour asked the Commission and the Audience to remain standing and have a moment of silence for the two Fire Fighters that were killed in the Porterville fire yesterday.

4.1 Approval of Minutes – Regular Meeting, January 22, 2020

Motion to Approve Consent Calendar made by Commissioner Chiesa, seconded by Commissioner Ernst. Approved 7-0 unan.

5.0 Regular Agenda

5.1 Approve the Stanislaus Regional 9-1-1 Fiscal Year 2020-2021 Proposed Budget

Stanislaus Regional 9-1-1 (SR911) Administration Service Manager John Bettencourt (Bettencourt) presented the Fiscal Year 2020-2021 Proposed Budget. Bettencourt shared that at the last Dispatch Advisory Board meeting the Board members asked staff to present a five (5) percent cost reduction in the budget. Bettencourt went over three different options which include Option A, regular budget with no changes; Option B, a five (5) percent vacancy rate; and Option C, a five (5) percent cost reduction. Staff is recommending Option A. Commissioner Ernst asked what is the operational impact of Option B and C. Bettencourt responded Option B is approximately 2 ½ Dispatchers and option C is 2 ½ Dispatchers and the other portion, to come up with the five (5) percent reduction, staff is predicting, based on historical data and current year projections, there will be \$130,000 in this year's Budget surplus which staff will use \$74,430 from the agencies contingency fund.

Motion to Approve the Stanislaus Regional 9-1-1 Fiscal Year 2020-2021 Proposed Budget using Option B, to include the 5% vacancy rate and return to the Board for final adoption with the final carry-over number to further consider part of the budget, made by Commission Lopez, seconded by Commissioner Wells. Approved 7-0 unan.

5.2 Accept the Consolidated Emergency Dispatch Agency Financial Statements for the Year Ended June 30, 2019

SR911 Bettencourt presented the 2018/2019 Financial Statements for SR911. A new audit firm was used this year, CliftonLarsonAllen LLP. Bettencourt shared the independent auditor's report issued an unmodified opinion on the financial statement, and an unmodified opinion for report on internal control over financial reporting. No management letter items or significant audit findings were identified.

Motion to Accept the Consolidated Emergency Dispatch Agency Financial Statements for the Year Ended June 30, 2019 Approved by Commissioner Chiesa, seconded by Commissioner Dirkse. Approved 7-0 unan.
