### -COPS Grants

All funds currently allocated except for \$385.

-Expecting Final Tait Contract Amendment for Fire Station 6 soon

Tait is going through the re-bidding process - Price will go up from last quote -4-5 months from procurement to completion (for Fire Station 6)

-Current Project Plan projects May 26th, 2016 Completion (for Fire Station 6)

Chief Carroll indicated he may be able to acquire some potential funding to pay for the tower at Fire Station 6. Hopefully swap Federal Grant Money intended to spend on towers with the funding Chief Carroll has found, to avoid waiting for FCC & FEMA. In the meantime we are to pursue the DHS funding. Also needs to let Sheriff Christianson know as he's working through the political structure to try to accelerate the approval processes that are holding up completion.

One will be MPD and the other will be Fire radio trainees. One dispatcher applicant is in background, and four part-time call taker applicants are in background.

Will be starting a new recruitment for part time call takers. Interviews will be in November. With the anticipated facility remodel in January, will push the training academy to February
