SR911 Executive Director Scotty Douglass called the Regular Meeting to order at 2:00 p.m.

    Scotty Douglass shared that SR911 closed out Fiscal Year 2016/2017 with \$99,366.78 surplus.

- 4.3 Agreement to Recommend and Forward to the Consolidated Emergency Dispatch Agency Commission the Allocation of Surplus Fiscal Year 2016/2017 Funds to Support the Purchase of Capital Equipment in the Amount of \$42,681, Increased Training and Professional Services Budgets in the Amount of \$20,000, and the Remaining Surplus Funds in the Amount of \$36,685 to the Stanislaus Regional 9-1-1 Contingency Reserve Fund Scotty Douglass presented the following for consideration:
  - 1) replace the Stanislaus Regional 9-1-1(SR911) Administrative Phone System in an amount not to exceed \$10,000,
  - 2) purchase two (2) Tri-Band Portable Radios in an amount not to exceed \$16,000.
  - 3) purchase replacement Dispatch Candidate Testing Laptops in an amount not to exceed \$16,681,
  - 4) designate \$20,000 equally split between Fiscal Year 2017/18 budget objects Training and Professional Services respectively, and
  - 5) allocate the remaining surplus funds in the amount of \$36,685 to the SR911 Contingency Reserve Fund.

4.4 Approve Law Enforcement Policy No. 610, MDC Dispatch / Communications / CHAT

4.5 Agreement to Recommend and Forward to the Consolidated Emergency Dispatch Agency Commission Administrative Policy/Procedure 201, Dispatch Advisory Board By-laws

Scotty Douglass recommendation is take what's in the JPA agreement concerning the Joint Powers Authority oversight of the Dispatch Advisory Board and create by-laws. Within that agreement it states the Dispatch Advisory Board is authorized to adopt by-laws. Douglass' recommendation is formalizing it in the by-laws to have it all in one location. The by-laws fully capture the structure and format of the Dispatch Advisory Board.

4.6 Agreement to Recommend and Forward to the Consolidated Emergency Dispatch Agency Commission the Early Replacement of the Stanislaus Regional 9-1-1 Dispatch Recording System in an Amount not to Exceed \$54,973

Scotty Douglass discussed that they discovered that the radio system console replacement, which is currently in progress, requires an interface to the recording system. In order to ensure that the new radio console transmissions

will be recorded it will be necessary to either pay \$61,823 for an interface to the existing recording solution or the recommended option is to pay \$54,973 and replace the recording system approximately 18 months in advance. Skiles/Christianson unam. 4-0
